**French Language Immersion Trip – Thursday 22 – Monday 26 February 2024**

*(Current Year 9 and Year 10 students who will be Year 10 and Year 11 at the time of the trip)*

I am delighted to inform you that the Languages Department have organised a trip to Paris for our upcoming Year 10 and Year 11 GCSE French students, from Thursday 22 – Monday 26 February 2024. We will be staying outside of central Paris and about 20 minutes from Disneyland Paris, which is the perfect place to discover the Parisian culture, and where students will take part in an exclusive French language immersion experience.

The trip will not only give students a fantastic opportunity to immerse themselves in Parisian culture, but it will also enable them to converse with native French speakers. All activities will be led in French enabling students to learn an extended level of vocabulary and learn new skills. Students who attend this trip return to their French lessons with a heightened level of confidence and understanding of the language, as well as some wonderful memories!

The trip is open to all GCSE French students currently in Year 9 and Year 10 (who will be Year 10 and Year 11 at the time of the trip). Whilst in France students will be able to participate in activities such as:-

- French Language Learning
- River cruise along the Seine
- Visit Stade de France
- Fly view
- Visit the Champs-Élysées
- Morning market
- Disneyland
- Visit Ile de la Cité

*(final itinerary to be confirmed)*

The total cost of this trip is **£760**, which includes the students' coach travel, accommodation, and all planned activities and sites we will be visiting. Food will be provided on a full board basis with packed lunches. All students attending this trip will require a valid passport and E/GHIC (European/Global Health Insurance Card) to be able to travel.

There are **30 places available** on this trip and they will be allocated on a first come first served basis (on payment of deposit via sQuid), with class behaviour taken into consideration. If you would like your child to go on this trip, there is a **non-refundable deposit of £100**, to be paid using your existing sQuid account. You will be able to do this **from 6pm on Sunday 9 July 2023** (closing date is **10pm Monday 10 July 2023**). For your information, the remaining payment dates are listed below. Please note that all payments can be made at any time but each one **must** be paid by the date stated:

**Please note:**

- *Places on all trips are subject to the school expectations for the Behaviour Policy being met. Any student who receives a suspension may have their place withdrawn from the trip and no refund will be made unless the place can be resold. In addition, if the school assesses that the attendance on a trip is a Health and Safety risk to the student or to others, a place will not be allocated to that student or a place will be withdrawn and there will be no refund made unless the place can be resold.*
- *Should your child be unable to attend a trip due to medical reasons, we will require a Medical Certificate to apply for an insurance claim.*
- *If the trip is cancelled due to uncontrollable circumstances i.e. weather, Foreign/Home Office guidance, the refunding of costs will be subject to insurance cover.*
- *If your child is, or has ever been in receipt of free school meals, then you may be eligible for assistance with the costs of this trip, from the school's Pupil Premium funding. The Pupil Premium funding is to be used for educational purposes only.*
- *Please note that Pupil Premium support for this trip is limited to 10% of the total cost of the trip and all requests should be made by 12 noon on Wednesday 5 July 2023.*
- *This trip is run via travel company: Voyager School Travel. To enable your child to attend the trip, we will be sharing your child's personal data with the travel company and any partners of the travel company that are required for the running of the contract (e.g. airlines, hotels, etc.).*
- *Payments are to be made by the dates specified. Late or non-payment may result in your child's place being withdrawn from the trip. If you choose to withdraw your child for reasons not stated above, any costs attributed to date, must still be made.*
- *Should the school need to contact you in an emergency, we will use contact details supplied on your most recent OA4 Form (off-site activity form). If there are any changes to the details on this form, including any medical or dietary requirements, it is the parent/carer responsibility to inform the school.*
- *This is an optional trip and is not essential to the curriculum or completion of the syllabus being studied.*
- *There will be no insurance cover due to disinclination to travel.*

**Travel Company Guidance**

**Passports**

On the day you travel, it is recommended that all UK passports must have 6 months of validity left and be less than 10 years old (even if it has 6 months or more left). We recognise that some EU countries only require 3 months validity, you should check the relevant government website for the exact requirements.

**Healthcare**

If you have a European Health Insurance Card (EHIC) you can continue to use this until it expires. If you do not have an EHIC or it has expired, you can apply for a Global Health Insurance Card (GHIC). Please visit the NHS website for further information.
